

## SABE CONFERENCE DRAWS 1,200 AND RAVE REVIEWS

Indianapolis and Indiana put their best foot forward in hosting the largest gathering of self-advocates in the country at the SABE 2008 National Conference – a conference organized, directed, and presented by people with developmental and other disabilities.

One of the major items of discussion at the town hall meeting was abolishing the use of the "R" word. It was enlightening to hear just how painful that word is to self-advocates. The discussion made clear that it is something that The Arc and those in positions of influence must address. Betty Williams, who did a tremendous job in helping to organize the conference, took that message back to the MR/DD Commission. A motion was passed by the commission to change the name to the Developmental Disability Commission.

Throughout the conference, keynote speakers provided inspiration, humor and leadership about the issues that are affecting people with disabilities across the country. We were fortunate to have a delegation from Canada with us to share progress they were making in addressing conditions in their institutions.

Both campaigns for President were invited to attend and address the conference. Senator Barack Obama sent the Director of Disability Voters, Kareem Dale, who not only presented but then stayed to talk with people late into the evening. Dale also showed a video message from Presidential Candidate Obama. He reported this was the most responsive group he has spoken to. The campaign of Senator McCain did not respond to the offer to send a representative.

The stories are legion of people who left the conference with new friends, new information and new energy for self-advocacy. It also left an impact on those Hoosiers who were there to volunteer and help. I cannot tell you how many people told me they were touched by the event, both self-advocates and volunteers, by what they learned. We will be a stronger state for self-advocacy because of this effort.
